The Share Rights are being issued to senior employees under the deferred component of Bapcor's FY23 Short Term Incentive Plan (STIP) which provides that, in respect of any short term incentive earned by Key Management Personnel (KMP) in FY23, 50% will be deferred for 12 months, and in respect of any short term incentive earned by senior employees that are not KMP in FY23, 25% will be deferred for 12 months. Until such time as the employee has achieved the "required level of shareholding" under Bapcor's Minimum Shareholding Policy, the deferred component is paid by way of Share Rights, which automatically convert to ordinary shares 12 months from grant date. Further details of the STIP are set out in the Company's Notice of 2023 Annual General Meeting, lodged with the ASX on 18 September 2023.
